

Stu Bledsoe Memorial Award



This leadership award is presented to an individual who the current graduating class of the Washington Agriculture and Forestry Education Foundation feels has made a **significant difference** in the natural resource industries in the state of Washington.

The Award is both a plaque presented to the recipient at the annual graduation banquet and a permanent plaque placed in the Foundation office that will list the names of all the award winners.

During the first class meeting the class will be informed of the tremendous contributions that Stu Bledsoe made to the AgForestry Foundation.

The class will be asked to seek out a nominee during their two-year program who, much like Stu Bledsoe, is making a difference for our natural resource industry. The class's nomination is presented to the Foundation Board, prior to the graduation banquet for official approval. The recipient of the award will be invited to attend the graduation banquet where the award will be presented to the winner by the graduating class.

CRITERIA FOR AWARD WINNERS

- 1. Is an active leader or has had a distinguished career in either public or private life.
- 2. Has had as his or her area of influence some involvement in any of the natural resource industries.
- 3. The main emphasis for selection of the award winner will center on the theme "making a difference."

This award may be made posthumously. A narrative about the individual will be archived at the Foundation office. The family of Stu Bledsoe will be notified of the name of the award winner each year.

THE PROCEDURE FOR NOMINATION

- 1. The class participants will choose a Stu Bledsoe Leadership Award Selection Committee. The Committee will receive nominations from the class.
- 2. At Seminar 11 in year two of the program, the selection committee will prepare a list of the top three nominees as ranked by the class participants.
- 3. The top nominee will be submitted, in writing, to the Executive Committee of the Board of Trustees for approval. The submission will be in the form of a resume which should be prepared as soon as possible following Seminar 11.

Jack Felgenhauer Leadership Fellowship



The Jack Felgenhauer Leadership Fellowship is established in recognition of Jack Felgenhauer of Spokane, Washington. His donation to the Foundation's Endowment Fund in 1994 has provided funds to support one seat in the program each year. Jack passed away on August 4, 2013, at the age of 92.

Felgenhauer's forward-looking leadership for the wheat industry, his dedicated and untiring promotion to build an understanding between rural and urban people, his deep concern about

telling the story of agriculture to the consuming public, and his recognition of the need for prepared and informed leadership for the industry prompted his contribution. Jack Felgenhauer exemplified leadership in the agriculture industry on a local, state, national, and international basis, as well as in public service and community involvement.

The Jack Felgenhauer Leadership Fellowship is a permanent fellowship which will support one leadership seat each year. The roster of participants will be reviewed each year and one participant from the wheat industry will be designated as the Jack Felgenhauer Leadership Fellow.

This appointment is made after the class has been approved through the established process. In the event a class does not include a wheat producer, another production agriculture participant is selected. Appropriate press coverage and publicity regarding the Fellowship is given each year.

<u>Carol Mercer</u> <u>Biographical Sketch</u>

Carol Mercer died on May 11, 1995, following a battle with cancer. She was born in Western Washington. For 20 years she lived in Everett and Seattle. In 1968, she moved to Eastern Washington and spent the last 26 years of her life residing in the Tri-Cities and Prosser.

Carol was president and owner of CMM Management Services, a consulting firm for various ag-related organizations and administrator for several non-profit agricultural associations.

Carol Mercer was an inspiration to many people. Her goal was to be vested in the successful, safe, and profitable continuation of agriculture, and to protect our fragile environment so future generations could supply the food that the world continues to demand. Carol's leadership reflected good listening skills, good communication skills, enthusiasm, clearly defined personal and professional ethics and an understanding of when to lead, when to follow and when to get out of the way.

Carol was not the type to sit and watch. She was actively involved in the following:
